

**Lake Rescue Association**  
**79<sup>th</sup> Annual Meeting**  
**Saturday, August 4, 2012**  
**Jackson Gore Inn, Cornerstone Room**

ROLL CALL: Board members – Angi Benson-Ciufo, Marty Fino, Frank Wingate, Charlie Robinson, Chris Salerno, Barb Silver-Holt. Members presents – See attached sign in sheet. *Natalie Fisher*

Frank Wingate called the meeting to order at 10:06 a.m. and all board members were introduced.

1. Remarks from President: Mary Rita is unable to attend the meeting. Frank Wingate read remarks from Mary Rita Batesole. (See Attached).
2. Annual Financial Report: Natalie gave an overview of the annual report. (See attached).
3. Presentation by Amy Picotte, Vermont Department of Environmental Conservation: Chris Salerno introduced Amy. Amy gave a presentation about the “Lake Wise Program”, a shoreline management program. Amy talked about the score card program which the state uses to assess the health of lakes, ponds and rivers. This is a new program to the state. They use our water samples that the lay monitors (the Norman’s) collect for us as well as information about our shoreline, lake habitat and aquatic invasive species.

Amy discussed shoreline protection and how important it is for a healthy lake. Amy reviewed data from a 2008 report about Lake Rescue which stated that Lake Rescue was a healthy lake experiencing increased sedimentation. Some of this is a result of water runoff and shoreline conditions.

Amy reviewed Lake Rescue’s scorecard. Our lake has good, long-term water quality trends. The shoreland received a “yellow” meaning that more than 50% of the lake has “lawns to lakes”. Lake Resuce received a “blue” (good) for evasive species. There is help available for homeowners who want suggestions on ways to stabilize their shoreline areas. Frank Wingate added that Lake Rescue changes its volume 12 times per year which is helpful for water quality.

4. Dredging application review and discussion: Charlie Robinson presented a slide show regarding TS Irene and the plans for dredging. Our biggest loss from Irene was Kevin Davis, longtime

board member, neighbor and friend to all. Charlie reviewed the concentrated areas of sedimentation that will be removed if the dredging project is approved.

LRA has performed four studies, the first being a visit from the DEC shortly after the storm. Mary Rita took them out on a pontoon boat and the boat ran aground during their tour.

Charlie reviewed a map that shows the difference in water depth between 2010 and then after Irene in 2011. There are many areas with water depth of 1' or less. The goal would be for a minimum of 4' in depth for safe passage.

The next study was in the summer of 2011 and winter of 2012. This was a core sampling project that the University of Vermont performed.

"Fins underwater" was performed by Chris Sheldon, our milfoil diver. He reported areas of concern with regard to water depth. Chris is familiar with our lake.

"Boots on the bottom" was performed by Geologist Bill Sheldon of Griggs- Lang. He surveyed the areas in the channel between Lake Rescue and Round Pond. This gave us good data to map the depth of the lake in this area.

Charlie showed the final map with lake depths and the areas for proposed dredging. Richard Killian asked for clarification for areas studied in the lake. Charlie reviewed the areas studied and also discussed a sandbar that at one point existed near "discovery island" that has since dissipated. The area around the Esau property was also studied but it was determined that navigation was not an issue so it was not pursued.

Charlie reviewed the dredging application process. Our application has been deemed complete by the state. The Board has also been working on preparing for the dredging process. We have been approved to use the Fishing Access largely because of help from Adam Greshen. The board had been unsuccessful in gaining approval for the use of the Fishing Access until Adam stepped in to help us.

The Board will most likely select AE Commercial Diving Co for the dredging contractor. The board spent a lot of time researching contractors and they have been determined to be the best fit for our project.

The projected calculation is 1200 cubic yard of material will be removed from the lake. Charlie reviewed the project total cost which is estimated to be \$70,000-\$100,000. An exact cost is not known due to the estimate of 1200 cubic yards are only an estimate. There may be slightly more or less materials removed and other factors such as transportation and removal of the fill material has an impact on the overall cost of the project.

5. Remarks from Frank Heald, Ludlow Town Manager: Frank informed the membership that he has brought his concerns about Money Brook to a number of State Agencies. He reported that the town is in good financial health. The non-resident tax rate has increased a little this year. The grand list was reduced with the reassessment that has just occurred. The Town has approximately 2.5M in Irene expense so far but he expects it to be over 3M by the time it is done. The state will fund 95% of these expenses.

Al Grant expressed concern and the need for guard rails along the entrance to Ellison Lake Road. Frank reviewed the existing conditions of the road and the catch basin that was installed after Irene. The catch basins were not acceptable to the Corp of Engineers and will have to be revised. When this work is done, there will be guard rails installed.

Members commended the town for their quick response from the town after the storm when they were able to get the roads in and out of the lake passable.

Richard Killian expressed concern regarding the sizing of the culverts under East Lake Road. Frank informed the membership that any culverts being replaced are being "up-sized".

A member asked for more clarification on the repairs to Red Bridge. Frank reviewed the work to be done to the bridge. It will not be a large structural modification, just some slight renovations.

6. Committee Reports:
  - a. Fund Raising: Barb informed the membership that approximately 50% of the Lake Restoration Fund will be utilized for dredging. The fundraising goal of \$50,000 has been set. Any additional monies raised will be used to replenish the Rescue our Lakes fund. So far, \$28,500 has been pledged and/or received.
  - b. Water Quality: Chris Salerno reported that a lot of information is available on our website as well as the state water quality website. We are applying for an ecosystem restoration grant. The State has \$2.5M available for grants. If successful, we would plan to utilize the grant to address issues in the lake's tributaries. We are still awaiting the results of the core samples from the UVM study. It will give us the makeup of the sediment and will graph when the layers of sediment arrived in the lake.
  - c. Membership Report: Charlie reported that last year there were 155 paid members. As of today there are 169 members which is an all-time record of LRA. There are still approximately 20 members who did not renew their membership from last year so the hope is that our count will go higher.

d. Milfoil Report: Frank reported that milfoil was first sighted in the lake in 1998. The last time any was found is 2004. There has not been any other lake in the State that has managed to remove the evasive weed from a lake. We have a grant for \$2,140.00 and the association has budgeted an additional \$2,000.00 for divers. The divers came two weeks ago and the divers had to stop due to poor visibility. Hopefully they will try again before the end of the month on a day that there is not a lot of boat traffic.

7. New Business:

- a. Election of new members: Charlie Robinson reported that 44 proxies were returned and Frank Wingate, Ann Rose and Alan Grant were all nominated for three year terms. Tracy Lowrey was nominated for a one year term but has since declined the nomination. The board will appoint someone to fill this one year term.
- b. Awards to retiring board members: Mary Rita Batesole, Glenn Brown and Christine Salerno were given plaques to thank them for their many years of service. The board thanks them for their hard work and they will all be missed.

Meeting was adjourned at 12:22 p.m.
