



















Purposes – LRA By-Laws:


- 1. Maintain, preserve, restore and improve those bodies of water within the Lake District, including but not limited to Lake Rescue, Round Pound, Lake Pauline, and the portions of the Black River and the watershed lying within the Lakes District (herein collectively "the Lakes");
- 2. Educate members and others as to the importance of the Lakes and to develop plans and initiate programs which will ensure a favorable ecological balance and good water quality;
- 3. Protect the Lakes from infestation by invasive aquatic nuisance species such as Eurasian water milfoil;
- 4. Work with the State of Vermont, the Town of Ludlow and private landowners to **prevent the erosion of road**material, sand and soil into the Lakes and to educate members and others as to soil conservation practices to control runoff;
- 5. Cooperate and work with the State of Vermont and the Town of Ludlow and adjacent towns in their efforts to **maintain the Lakes in good condition**;
- 6. Educate and encourage members and other users of the Lakes in all aspects of water safety such as safe boating, swimming safety and adherence to state boating regulations, by such means as publicizing the rules and erecting safety markers;
- 7. Promote a sense of common interest among members and encourage greater community awareness in preserving the Lakes as an invaluable natural resource for the entire region; and
- 8. Provide a forum for resolution of other pertinent matters of importance affecting the membership




Membership by Lake



Dredging Project

Permit Status

- In 2020, LRA filed a Lake
 Encroachment Permit Application
- Application approved August 7, 2020
- 5-year permit, expires August 7, 2025
- LRA decided to defer dredging in 2021





Approved Permit Summary

- Permittee: Lake Rescue Association
- Co-Permittee: AE Commercial Diving
- Dredging activities shall occur between Jul 1 and March 15
 - Dredging area in mouth of the Black River and into the Narrows
 - Removal of approx. 1,980 cubic yards
 - Project area 1.58 acres
 - Restore lake bottom to minimum depth of 3 to 4 feet in the project area
- Estimated cost \$125,000 (2020 estimate)
- Permit expiration August 7, 2025

Dredging Process – Next Steps

- Monitor and determine when dredging will begin however should be no later than Fall of 2024
- Update the Bathymetric report
- Schedule contractor, reserve equipment and purchase materials
- Apply to VT Fish and Wildlife for Special Use Permit
- Identify area to dispose of sediment removed from lake



Catch Basins and Roadways


- LRA continues to monitor sediment build up in catch basins and ditches along roadways.

Ludlow Stormwater Master Plan (SWMP)

- VT DEC monitors 10 watersheds in the state
- Basin 10 Ottaqueechee/Black River Watershed
- Mt. Ascutney Regional Planning Commission (MARC) planned SWMP update for our watershed > 1 year ago
- Fitzgerald Environmental Consultants hired to assess stormwater issues in Ludlow
- Assessment of issues LRA identified around Lakes Rescue/Pauline was important part of study
- LRA meeting with Evan Fitzgerald summer 2020



SWMP

- In June 2021, the SWMP report was completed by MARC.
- 2 areas (LR-1 Norman & Tepper Drive, LR-6 Red Bridge Road) selected for conceptual design development
- The report recommended that these areas be considered for further development
- LRA will communicate with town of Ludlow as they and MARC identify funding for these projects, in particular state Clean Water Grants
- Once projects funded and completed, LRA will work with town of Ludlow to ensure improvements are maintained








Stream Crossing East Lake Road South of Archibald Lane (LR-5)

- Ludlow applied for Better Roads Grant December 13, 2019
 - Upgrade culvert
 - Reshaping swale and stone lining for the stream
- This project was not approved for Better Roads grant in 2020 and will be resubmitted in fall 2021.





Measures to Control Milfoil

- Bottom barriers 48
- Boat greeter program
- Extraction methods
 - Hand pulling rooted plants
 - Divers and trained homeowners
 - Netting floating fragments
 - Volunteer patrols
 - Diver Assisted Suction Harvesting




Lake Pauline Milfoil Map, July 2021



WHAT YOU CAN DO WHILE recreational boating, water skiing, tubing wake-boarding...

Boat props shred plants → floating fragments

Every fragment can produce multiple plants

Remove floating fragments and dispose on land


Avoid boating in shallow areas: Keep props up

Do your best to stay inside of red arrows

Moving Forward

- Continue barrier strategy
 - Barriers kill milfoil in approximately 4 weeks
 - Opportunity to relocate barriers after 8 weeks
 - Relocation strategy could double the yearly impact (up to 96 milfoil locations)
- Diver harvesting
 - LRA plans to continue 3 harvesting visits per week 2 with DASH boat, 1 hand pulling
- Resident harvesting
 - Vermont allows shallow water weed removal
 - Remove ONLY using proper technique
 - Board will provide guidance on technique to safely remove plants from shallows
- Continual reevaluation
 - Board is committed to reevaluating and alter course as necessary








State Dock Update

- Quick review
- Current status
 - Court rulings dormant until June 2021; now actively preparing for trial
 - Judge site visit August 18
 - Preparing for Environmental Court hearing this fall, likely November
- Costs
 - to date, are on budget to spend ~ \$20,000 net total through trial, approved last year, which includes realized and projected donation offsets
- Next steps
 - follow through to trial
 - outcome uncertain






Boating Safety

 - Rules of the road and PFD requirements
 - Licenses/registrations
 - Milfoil boat checks
- LRA recommendations
 - Boating times (8 a.m. after dusk)
 - Counter-clockwise boating
 - Slow-wake buoys







Frank Wingate
