

Who we are, what our mission means and what it doesn't



### Purposes – LRA By-Laws (proposed 2022):

- 1. Maintain, preserve, restore and improve those bodies of water within the Lake District, including but not limited to Lake Rescue, Round Pound, Lake Pauline, and the portions of the Black River and the watershed lying within the Lakes District (herein collectively "the Lakes");
- **2. Educate members and other community members** as to the importance of the Lakes and the mission of the LRA as a voluntary non-profit organization (rather than a homeowners' association with enforcement powers);
- 3. Develop plans and initiate programs which will ensure a favorable ecological balance and good water quality;
- 4. Work to mitigate the presence of invasive aquatic nuisance species, such as Eurasian water milfoil from the lakes;
- 5. Work with the State of Vermont, the Town of Ludlow and private landowners to minimize the erosion of road material, sand and soil into the Lakes and to educate members and others as to soil conservation practices to control runoff;
- 6. Cooperate and work with the State of Vermont and the Town of Ludlow and adjacent towns in their efforts to maintain the Lakes in good condition;
- 7. Educate and encourage members and other users of the Lakes in all aspects of water safety such as safe boating, swimming safety and adherence to state boating regulations, by such means as publicizing the rules and erecting safety markers;
- 8. Promote a sense of common interest among members and encourage greater community awareness in preserving the Lakes as an invaluable natural resource for the entire region; and
- 9. **Provide a forum for resolution** of other matters of importance affecting the membership and that pertain to the mission to maintain and restore the Lakes.

  - LRA Reserve Replenishment


# Key Results to-date from Fundraising:

## **Dredging Project**

- In 2020, LRA filed a Lake Encroachment Permit Application
- Application was approved on August 7, 2020
- 5-year permit, expires August 7, 2025
- Deferred dredging in 2021 and 2022
- Planning to dredge Fall 2023
- Provides 1-year cushion for any unforeseen delays





### Approved Permit Summary

- Permittees: Lake Rescue Association
- Co-Permittee: AE Commercial Diving
- Dredging activities shall occur between July 1 and March 15
  - Dredging area in mouth of the Black River and into the Narrows
  - Removal of approx. 1,980 cubic yards
  - Project area 1.58 acres
  - Restore lake bottom to minimum depth of 3 to 4 feet in the project area
- Estimated cost \$125,000 (2020 Estimate)
- Permit expiration August 7, 2025



# Project Area

### Dredging Process – Next Steps

- Monitor and determine when dredging will begin however cannot be later than Fall of 2024
- Schedule Bathymetric report for October 2022
   Proposal from Griggs Lang for \$1,800
- Compare updated Bathymetric report to current permit to confirm or amend project area.
- Schedule contractor, reserve equipment and purchase materials
- Apply to VT Fish and Wildlife for Special Use Permit
- Identify area to dispose of sediment removed from lake



### Catch Basins on Roadway Around Lakes

- LRA continues to monitor sediment build up in catch basins and ditches along roadways.
- Thank you to Town of Ludlow for cleaning out catch basins and ditches in June 2022.
- On June 22, 2022, LRA met with Plymouth Select Board members and Marie Caduto VT-DEC regarding mitigation of sediment flowing from Patch Brook. No plans at this time.




### Ludlow Stormwater Master Plan (SWMP)

- In June 2020, the SWMP report was completed by the Mount Ascutney Regional Commission (MARC).
- 2 of the areas (LR-1 Norman & Tepper Drive, LR-6 Red Bridge Road) were selected for conceptual design development
- In March 2022, MARC informed LRA and Ludlow that the funding is "inhand" for both LR-1 and LR-6.
- Does not require any matching funding from Town of Ludlow
- On July 29, 2022, MARC indicated:
  - Planning and permitting would begin on LR-1 Norman & Tepper Drive the week of August 1 Indicated that it is not likely to go to construction until next year (2023)
- MARC also indicated that LR-6 will need property owner approval before any further action can be taken.



# Drainage locations

- 6 problem areas identified
- 2 circled in red selected
- L6 requires property owner approval





# Better Roads Project for stream crossing East Lake Road south of Archibald Lane

- LRA has been working for a grant for this work since 2018
- Ludlow re-applied for Better Roads Grant December 13, 2021
  - Upgrade culvert
  - Stone lined ditch and headwalls
- This project was approved in May 2022 for a Better Roads grant
- Project expected to be completed Fall 2022
- Awarded 80% of cost up to \$16,600.00
- Construction work and final report paperwork must be completed by June 30, 2023

### Measures to Control Milfoil

- Bottom barriers 63
  - Added 15 barriers this season
- Boat greeter program
- Extraction methods
  - Hand pulling rooted plants Divers and homeowners
  - Netting floating fragments
  - Volunteer patrols
  - Diver Assisted Suction Harvesting



### Hand pulling

- Step One: Gently reach behind the plant with your palm or small hand rake towards you and your fingers/rake pointed downward.
- Step Two: push your fingers/rake into the bottom behind the plant stem (as far as you can, if necessary, and pull towards you. Your fingers/rake should be below the root crown of the plant.
- Step Three: When you have the bottom of the stem in your grasp, pull it upwards out of the bottom. Use your hand as though it were a rake.



## Program for balance of 2022 season

- Bottom barriers will be relocated to other problem areas in the next week or two
- LRA plans to continue 3 harvesting visits per week –2 with DASH boat, 1 hand pulling in Pauline when needed
- Resident harvesting, spotting and marking
- Continual strategy reevaluation







## State Dock Update

- VT Fish and Wildlife Department filed for encroachment permit in 2018 to install a 48 foot "ADA" compliant boat dock at the Lake Rescue fishing access boat ramp.
- All comments filed during the public comment period, and at a public meeting from local stakeholders expressed concern and problems with the state's plan.
- Nevertheless, The agency for Natural Resources, the parent organization of Fish and Wildlife, approved the application.
- The Lake Rescue Association and some adjacent homeowners filed for appeal with the Vermont environmental court.
- Because of Covid the case has been delayed.
- Our attorney, George McNaughton of Springfield, Vermont unexpectedly passed away this spring.
- We've hired replacement counsel, AJ LaRossa, an environmental attorney in Burlington, Vermont.
- We expect to go to trial in December







# **Boating Safety**

- Vermont boating laws
  - Speed limits (5 mph 200' from shore or obstacles)
  - Rules of the road and PFD requirements
  - Licenses/registrations
  - Milfoil boat checks
- LRA recommendations
  - Boating times (8 a.m after dusk)
  - Counter-clockwise boating
  - Slow-wake buoys
- Wake boats/slow wake buoys
- Role of the LRA <a href="https://lakerescue.org/boating/">https://lakerescue.org/boating/</a>
- Responsibility as a lake community member
- Reporting inappropriate activity/violations: state police/ game warden
